Attachment #3 – Constitution Amendment Proposal



Dated this 13th day of November, 2012

Proposed Amendment to the Constitution Article III Membership Section 1

Individuals must be a United States Citizen or Legal Immigrant, never been convicted of a felony or any other crime of violence and Legally able to possess a Firearm in the State of Pennsylvania and the United States, in order to be eligible for and maintain a Membership with The York Rifle Range Association Inc.

Amend as follows:

Add: and starting January 2013, must be a current member and maintain membership with the National Rifle Association, known as the NRA.

To read as follows:

Individuals must be a United States Citizen or Legal Immigrant, never been convicted of a felony or any other crime of violence, Legally able to possess a Firearm in the State of Pennsylvania and the United States and starting January 2013, must be a current member of the National Rifle Association, known as the NRA, in order to be eligible for and maintain a Membership with The York Rifle Range Association Inc.
